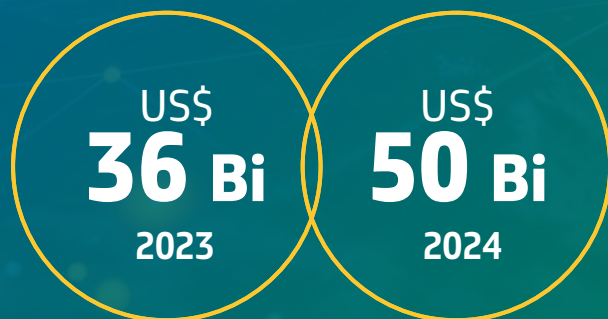

Requirements and criteria evaluated



In order to verify if suppliers meet the necessary requirements, we evaluate the following criteria:



LEGAL

Verification of the company's legal and fiscal compliance.



ECONOMIC-FINANCIAL

Economic-financial status (Net Worth and Liquidity and Leverage levels)



TECHINICAL AND HSE

Ability to meet technical requirements and Health, Safety, and Environment (HSE) requirements

To be eligible to provide services in Brazil, it is mandatory for the supplier to set up a company in the country.

Petrobras conducts pre-qualification processes in order to qualify suppliers for its complex bidding processes.

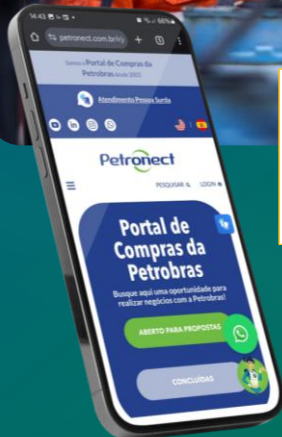
